

THE KOREAN LANGUAGE TEST AS A REPLACEMENT OF TOPIK

Test-Related Guidance

- Students who do not satisfy the HYU Korean language standard can attend the Korean language test conducted by Hanyang University.
- If test taker pass this test, Korean language standard will be changed to 'PASS' automatically.
 - Those who want to enter Hanyang University should pay the deposit and tuition fee regardless of the test result. Even if students pass the Korean Language Test, admission will be canceled if the students don't pay the deposit and tuition fee.

Result Announcement

Jan. 4th(Mon), 2021 2pm

- 1) The Korean test is conducted online and only the test taker can attend the test.
- 2) The test taker must be in an isolated area without interference from others.
- 3) Test takers will be disqualified if the test is not taken or does not access to the program by the specific time mentioned.
- 4) Test takers must bring their passport or ID card. Those who do not have a valid ID will be restricted from taking the test.
- 5) If test takers do not comply with supervisor's instructions or do suspicious eye movement or do unnecessary movement during the test time, it will be regarded as cheating. The test may automatically end which will result in failure of the test.
- 6) Admission may be canceled if improper behavior is caught.
- 7) The exam session will be recorded all the time and can be used as evidence. If there are any situations which can lead to disadvantages such as unstable network environment, it is the test taker's responsibility.
- 8) If test takers take an exam on a wireless Internet (WIFI) or an unstable network environment, you may lose network connectivity and face disadvantages.
- 9) The Korean test will be conducted only once. Please be sure to read guidelines and attend the orientation before taking the test.
- 10) Details about the online exam will be notified by email.
- 11) Those who pass the Korean test can start their degree program in Spring of 2021.
- 12) Those students who don't pass the test should apply for a leave of absence after tuition payment.

SELF-QUARANTINE

Self-quarantine

- 1. Those subject to self-quarantine: All inbound passengers entering Korea (both on direct flights and for stopovers)
- 2. Self-quarantine period: Until 12:00 PM of the 14th day from the day of entering Korea ex. If entering Korea on 1st Feb., mandatory to be quarantined until 15th Feb. 12:00 PM.
- 3. Facilities not available for self-quarantine: Multi-use facilities, crowd Facilities (Hotel, guest house, a room for more than 2, etc.)
- 4. Facilities available for self-quarantine
 - 1) The place written on valid ARC (With no roommates)
- 2) Hanyang University Temporary Off-campus Dormitory (students who are not able to find self-quarantine facility on their own can apply for temporary dormitory)
 - Self-quarantine application website: www.globalenskr.com
 - Self-quarantine application period: from Jan 4th 2021
 - Regarding the operation period of residence and the cost, please check the detailed information on the website above after Jan 4th 2021.
- × 2021 Spring semester will start on Mar 2nd, 2021. So, please decide the date of arrival with considering the self-quarantine period(14 days)
- **X** Students are not allowed to take self-quarantine in the dormitory on the campus.

SELF-QUARANTINE (SEOUL CAMPUS)

Caution for Self-quarantine

- Those who do not fully comply with self-quarantine orders will face up to 1 year in prison or a 10-million won fine
- If one incurs any loss in the nation due to violation of self-quarantine instructions, he/she may be subject to claims for damages.
- Those who violate the self-quarantine instructions will be responsible for his/her COVID-19 medical expenses.
- If one leaves his/her quarantine area without permission during the quarantine period or otherwise fail to comply with quarantine guidelines, he/she will be required to wear a safety band on wrist. If one still refuses to comply, he/she will be ordered to quarantine at a government facility. (Fee to paid by the violator)

ADDITIONAL DOCUMENT SUBMISSION

Additional Document Submission

- **X** If you did not submit any of original documents below, please submit by Feb 26, 2021. (Successful candidates will be notified of their additional documents via e-mail.)
- (1) If you did not submit the documents or have submitted photocopied documents of transcripts, certificate of graduation and etc., you must re-submit the consul's confirmation documents or apostille certified copies.
- (2) Applicants who submitted expected graduation or enrollment certificate of high school or former university must submit certified copies of graduation and final transcripts to the Office of International Affairs as soon as they are issued.
- (3) Transfer students must submit the final certificate of graduation and transcripts following the guidance if they haven't submitted yet. (** Transferred students should submit the certificate of the final transcript by Jan 29, or your former school credits might not be transferred. If submitted late, students will face all of the disadvantages.)
- (4) If students have submitted the scanned file or English notarized documents, you must re-submit all of the documents following the admission guidelines.

▶ NOTE

Please note that your admission is completed only when the above documents are submitted by Feb 26, 2020. If the documents are not submitted by the deadline, your admission will be cancelled.

LEAVE OF ABSENCE

Info about Leave of Absence

- 1) Those who do not satisfy Korean standards do not need to apply for a leave of absence as it will be automatically processed by OIA for the first semester of admission in the first week of March.
- 2) Students can take a leave of absence up to 1 year at a time. If you want to take a leave of absence in a row or re-register, you need to visit HY-in Hanyang university online portal system for apply it. (Maximum duration of Leave of absence : 3 years)

NOTE

- 1) Those who do not satisfy Korean standards should take a leave of absence. If not, the tuition fee will not be saved.
- 2) Students who do not satisfy Korean standards cannot apply for Student(D-2) Visa as they have to take a leave of absence for the first semester.
- 3) Those who applied for Hanyang Univ. Institute of International Education(IIE) can receive language training(D-4) visa Standard Certificate of Admission from Hanyang Univ. IIE.
- 4) Students can re-register during the re-registration period if they satisfy Korean standards. (re-registration application period: January spring semester, July fall semester)

HANYANG SIBLING SCHOLARSHIP

Hanyang Sibling Scholarship

- 1) Qualification: Students whose brother or sister is registered as a full-time student at undergraduate school of Hanyang University
- 2) Required documents: 1) Enrollment certificate (or leave of absence certificate)
 - 2) Family relationship certificate
- 3) How to apply: Submit the required documents above to the Office of International Affairs by Jan 29, 2021
- 4) Scholarship: 50% of Tuition (One semester only)

Guideline for English Placement Test(1)

1. All undergraduate international students for 2021 Spring semester required to take English Placement test (Except for transferred students, International studies and Data Science Students and those who exempted from the test cannot take Basic Academic English or Professional Academic English during their school years.)

2. Test Duration

- 1) Type: ①Reading & Listening ② Essay Writing
- 2) Duration: 90 mins(Students who do not take all of the tests will be automatically assigned to the lowest level.)
 - ① Reading & Listening: 60 minutes
 - 2 Essay Writing: 30 minutes (for checking the essay topic, writing an essay, and submitting an essay file)

3. Test Time

- 1) Date: Feb 2, 2021 (Tue) 10:00 Feb 4(Thu) 23:59 (Korea Time)
 - > Students can take the test at their convenient time during the test period, through a URL provided later.

4. Method: Online test

- 1) Manuals for test takers will be provided later.
- 2) What is needed: Application number, Computer, Internet access
- * Proper internet setting needs to be set up to take a test. Any issues occurring due to not following the instructions will be your sole responsibility and will result in being assigned to the lowest level.

Guideline for English Placement Test(4)

- **X** Students who fail to take the test will be automatically assigned to level C.
- **X** There will be 3 BAE and 3 PAE courses for International students only. If students with high proficiency register these courses, their registration will be cancelled at the discretion of the professor.
- ** Those Students who exempt from English Placement Test like transfer students, International Studies and Data Science major students cannot take Basic Academic English (BAE) or Professional Academic English (PAE).
- * It is strongly recommended to take a Professional Academic English in your 2nd year. Postponing this course to a later semester might cause a delayed graduation as the last two years of university will be mostly spent on taking major courses.

GROUP VISA APPLICATION GUIDELINE

Group Visa Application Guidelines

It is a principle to apply for Study Visa (D-2) and alien registration card by visiting the immigration office individually. However, due to the COVID-19, OIA will receive group visa application in February or March. Details (application period, requirements, application fee, etc.) will be notified via e-mail only to those who have paid their tuition fees and are eligible.

LEAVE OF ABSENCE

Leave of absence

1. Apply for Leave of absence

- Subjects: Only for students who would like to apply for the leave of absence due to COVID-19

- (1) Those who do not satisfy Korean standards should take a leave of absence. If not, the tuition fee will not be saved.
- (2) If students apply for leave of absence, the issued certificate of admission will be invalid. And when you apply for the reregistration, you should apply for the certificate of admission again.

 - If students do not apply for the re-registration, their academic status will be changed as "expelled".
