4 Guidelines for Submitting Bank Balance Certificate

- Bank balance certificate provides the proof of financial ability necessary for issuing a D2 study abroad visa, and only those who are applying for D-2 VISA among the accepted applicants will be required to submit it. The details of submission criteria and deadline will be noted to the accepted applicants after the result announcement.

03 Eligibility

Type	Eligibility
Freshman	Nationality : Applicants with foreign nationality whose parents both have foreign nationality. - Eligible if both the applicants and their parents obtained foreign nationality before entering high school. - If the applicants and their parents have dual citizenship, they should both renounce their Korean citizenship before the applicants enter high school. Academic background : Applicants who graduated or are expected to graduate from high school.
Transfer	Nationality : Applicants with foreign nationality whose parents both have foreign nationality. - Applicants and their parents must have held foreign nationality for more than 3 years prior to the application date. - If the applicants and their parents hold dual citizenship, both must have renounced their Korean citizenship more than 3 years prior to the application date. Academic background : Applicants must be enrolled in a four-year university or have graduated from a vocational college. - four-year university(include a three-year or five-year bachelor's program) : eligible if the applicant completed or is expected to complete at least two years (four semesters, excluding summer/winter sessions) - Vocational colleges: eligible for graduate or expected to graduate with a vocational degree - For applicants who are expected to complete or a graduating students: eligible if the applicant is able to submit his/her final academic documents before the semester begins Major : Applicants who intend to apply for a department or major at Hanyang University similar to their previous university major.

<Notice on Eligibility>

※ If the applicant submits any forged documents with regard to eligibility, his/her admission will be revoked.

※ The applicant must submit additional documents if he/she is requested to do so during the document review. The applicant may be contacted individually, if needed. Any disadvantages from providing incorrect contact information or failing to respond to us are the responsibility of the applicant.

[Notice on nationality]

1. Applicants (or their parents) holding dual nationality, including Korean citizenship, are not eligible to apply as international students. Admission will be revoked if such status is discovered after acceptance.

2. If the applicant has any significant status with regard to family relationships and/or nationality (divorce, remarriage, single parent, death, missing, acquisition of Korean citizenship, etc.), he/she must submit documents to prove it.

e.g.) certificate of divorce, certificate of family relationship, certificate of single parenthood, certificate of death, certificate regarding missing person, confirmation of obtaining Korean citizenship

※ If the applicant's father or mother has remarried a Korean national, the applicant must submit the Korean national's (detailed) certificate of family relationship.

※ (For Chinese nationals only) A certificate of death may be replaced with one of the following documents.

- ㉓ Original Notarized Cancellation of Registration Certificate
- ㉔ Original Notarized Family Certificate that verifies the death

3. Acceptable period regarding the change of family relationship

- Freshman : Those whose family relationship has changed before the applicants enter high school are acceptable.
- Transfer : Those whose family relationship has changed 3 years before the application period are acceptable.

[Notice on academic background]

1. Expected graduates or applicants who are expected to complete must submit their certificate of graduation or certificate of completion before the start of the semester they will enter. Otherwise, their admission will be revoked.

2. The applicant's admission will be revoked if anything in his/her academic background is found to be non-certified or not recognized in the country of the school's location.

3. Some types of academic background, such as home-schooling, cyber learning, adult education, and high school graduate equivalency test, are not acceptable.

4. Applicants who graduated from a Five-year education school in China are not acceptable.

5. Applicants may not apply with a provisional or temporary certificate of graduation, as such documents are not recognized as a formal certificate of graduation.

<Instructions for Document Submission>

- In principle, all required documents must be prepared according to the given criteria and submitted by the application deadline.
※ If the applicant fails to submit the original apostilled or consular-certified documents, any disadvantaged from the documents submission are the responsibility of the applicant.
- All documents must be submitted to the OIA by post.
- All submissions must be on A4-size paper and submitted in the order in which they are listed in the document list.
- Documents that are not written in Korean or English must be accompanied by notarized translations into either language, if the applicant has problem with notarized translation, please contact the admission office.
- Accepted students who are expected to graduate at the time of application MUST submit their final academic certificate with Apostille certification or consular authentication. (If the document is not submitted, admission may be revoked.)
- Please contact the relevant institution for information on document verification and prepare application documents. (See Appendix 2.)
- Proof of family relationship by country (examples):

- If there are any discrepancies in the applicant's documentation after the educational background check, his/her admission may be canceled, even after being admitted.
- Other supporting documents (such as a certificate of achievement or a license) must attach the original copy of Korean or English translation.
- The validity period for notarization is six months (Only valid for documents issued after March 2, 2025), while apostilled documents have no expiration date.
- ALL submitted documents including supporting materials will NOT be returned to the applicants. We advise applicants to prepare additional documentation for visa applications.

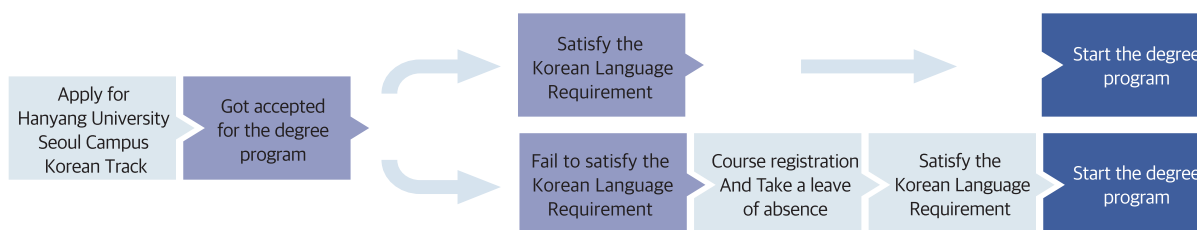

07 Korean Language Proficiency Standards

Hanyang University prioritizes the assessment of applicants' academic abilities. Therefore, the results of the acceptance are determined based on academic abilities, regardless of meeting the Korean language requirements. The Korean language requirement of Hanyang university is only for the start of the degree program for applicants for Korean track majors. The accepted applicants who do not meet the Korean language requirement in their admission, must take a leave of absence and study Korean until they meet the requirement. Once the Korean language requirement is met after the leave of absence, they can apply for re-enrollment and start their degree program. (The maximum period of leave of absence follows the university's leave of absence regulations.)

08 Undergraduate Dual Application

Admissions for the Seoul and ERICA campuses are managed separately, and dual applications for the 1st and 2nd choices are available for the Seoul Campus. If you apply to both the Seoul and ERICA campuses and are accepted, you can only register for one of them.

A. Dual Application Criteria

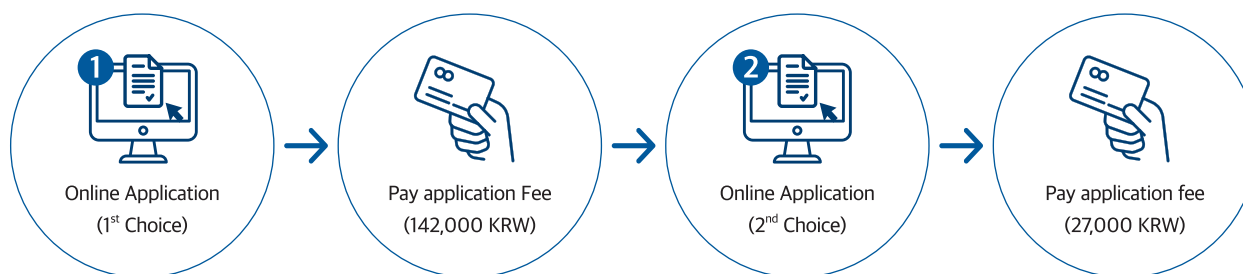
Seoul Campus applicants may make a single or dual application.

B. Dual Application Process



※ Applicants who wish to make a dual application must apply online twice. If applicants do not complete the payment of the 1st choice application fee, they will not be able to create a new application for the 2nd choice.

Dual applicants must prepare the documents required by the departments to which they apply. However, only one copy is needed for educational and nationality-related documents.

E.g 1 When applying for a major that requires document evaluation in the 1st choice and artwork screening in the 2nd choice, artwork for the 2nd choice major must be submitted.

E.g 2 If artwork is required for both the 1st and 2nd choices of majors, artwork must be submitted separately for each.

C. Dual Application Selection process

Applicants will first go through document evaluation and artwork screening for their 1st choice. Those who did not pass admission for their 1st choice will automatically be considered for admission to their 2nd choice.

D. Check the Results and Register

The results can be viewed on the OIA website by entering the applicant's application number and date of birth. Dual applicants should check the results for each application by entering the application numbers accordingly. **If applicants are accepted for their 1st choice, their 2nd choice application will be automatically rejected, and they must register for their 1st choice.**

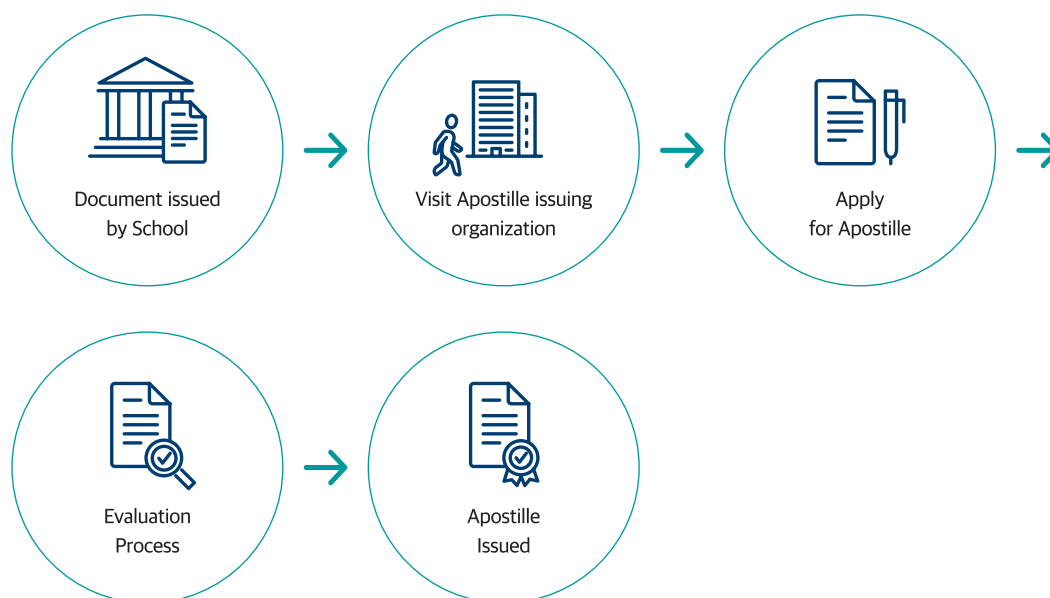
1 Introduction for submitting a document to prove the academic history from overseas institutions

All applicants must submit an official diploma or degree and an official academic transcript verified by one of the following verification method stated below during the designated period.

- Apostilled Official diploma or degree and official academic transcript
- Official diploma or degree and official academic transcript verified by a Korean Embassy

2 Graduates from Apostille member countries

- Apostille Convention
 - 1) The Republic of Korea became the 90th Contracting State of the Apostille Convention (Convention Abolishing the Requirement of Legalization for Foreign Public Document), effective as of July 14, 2007
 - 2) Apostille is a certificate specifying the modalities through which a document issued in one of the signatory countries can be certified for legal purposes in all the other signatory states
 - 3) Apostille convention countries abolish the complex consular procedures to ensure the mutual authentication of public and official documents (Apostilled documents have the same effect as documents verified by diplomatic offices)

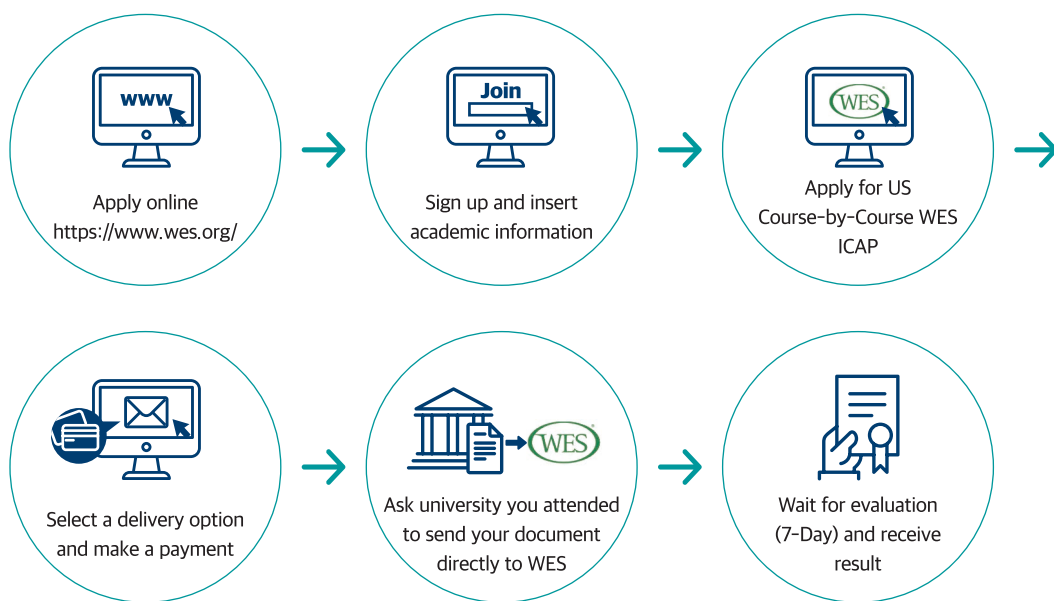
